DataCite Canada Consortium January 1, 2024 – December 31, 2024 PARTICIPATION AND FINANCIAL COMMITMENT AGREEMENT

I have reviewed the financial commitment and terms and conditions required to participate in the *DataCite Canada Consortium* for the period of January 1, 2024 – December 31, 2024.

I understand that pricing is composed of one element: a 600 OR 700-euro organization fee, depending on the number of members as of January 1, 2024. This fee will be subsidized by funding from the Digital Research Alliance of Canada based on the total number of DOIs my organization registered in 2023, as outlined in the following tiered fee models and the attached spreadsheet (filename: 2024 Fee Model - DataCite Canada Consortium.xlsx). These fees may be subject to change before December 31, 2023, as my organization continues to register DOIs and could change tiers:

Model 1 (600-euro fee cap; greater than 60 members)

• Tier 1 (0-99 DOIs)	€65	€535 subsidized by the Alliance
• Tier 2 (100-999 DOIs)	€180	€420 subsidized by the Alliance
• Tier 3 (1,000-9,999 DOIs)	€250	€350 subsidized by the Alliance
• Tier 4 (10,000+ DOIs)	€2,350	€250 subsidized by the Alliance

Model 2 (700-euro fee cap; 60 members or less)

• Tier 1 (0-99 DOIs)	€120	€580 subsidized by the Alliance
• Tier 2 (100-999 DOIs)	€360	€340 subsidized by the Alliance
• Tier 3 (1,000-9,999 DOIs)	€505	€195 subsidized by the Alliance
• Tier 4 (10,000+ DOIs)	€2,650	€50 subsidized by the Alliance

I recognize that CRKN cannot predict or guarantee the market foreign exchange rates in effect at the date of invoice or settlement, and that CRKN seeks competitive rates at any given point in time. The above tiered fees may be adjusted in minor ways based on the final number of members and the final number of DOIs registered by each member in 2023.
