


# 86% of the Bibsam organisations' publishing is covered by Bibsam agreements

## **Beyond transformative agreements working group**

2021 The Swedish Rectors' Conference initiated the Beyond Transformative Agreements working group (the BTA group)


#### **Purpose**

To further advance the transition to open access by developing a strategy beyond transformative agreements on how Sweden (Bibsam) should operate in the coming years.

Examine alternate publishing routes and suggest measures.

#### **Timeframe**

March 2021 – December 2023. Draft finished by end of 2022/beginning 2023 to be used in upcoming negotiations.



### Working group phases and process



#### **Council conclusions- EU**

- High-quality, transparent, open, trustworthy and equitable scholarly publishing (May 23<sup>rd</sup>, 2023)
- Calls for immediate and unrestricted open access in publishing research involving public funds
- The costs of paywalls to access and publish articles are becoming unsustainable
- Calls on the member states to support policies towards a scholarly publishing model that is not-for-profit, open access and multi-format, with no costs for authors or readers
- Encourage member states to support the pilot programme Open Research Europe to create a large-scale open access research publishing service

### National guidelines – Swedish government

- On behalf of the Swedish government, the National Library of Sweden (Kungliga biblioteket, KB) has developed <u>national</u> <u>guidelines for open science</u> (Jan. 2024).
- Goals and priorities for open science in Sweden, divided into six areas:
  - Open access to scholarly publications
  - Open access to research data
  - Open research methods
  - Open educational resources
  - Public engagement in science
  - Infrastructures supporting open science
- Provides support and guidance to actors in Sweden, mainly research performing and research funding organisations.
- Aligned with the <u>UNESCO Recommendation on Open Science</u>.

#### **Recommendations – SUHF**

- Recommendation (Nov. 2023) from the Association of Swedish Higher Education Institutions regarding charting Sweden's path beyond the transformative agreements:
- that it is crucial that **control over scholarly publishing remain within the academic** community, but also that the **costs of publishing decrease**.
- that the Bibsam Consortium should not primarily enter into agreements for reading and publishing in so-called hybrid journals (i.e., it should not continue to sign transformative agreements). It should instead only negotiate agreements for publishing in open access journals. This approach should be implemented from 2026 and apply to all open journals, regardless of the publisher.
- that an aim should be to manage costs for academic reading and publishing at the national level as much as possible, in collaboration between higher education institutions, funders, and the National Library of Sweden, that is, within the framework of the Bibsam Consortium

### **Supporting strategic initiatives/measures**

- Agreements with publishers that exclusively publish open access journals should be developed.
- Provide a independent publishing platform that also includes peer review of published articles. One possible route could be to join the EU platform, Open Research Europe (ORE).
- The possibilities for migrating researcher-owned journals from traditional publishers to other platforms should be expanded and encouraged.
- Continuing work on copyright issues for open access is important but dependent on international developments in the copyright field, mainly within the EU.

#### Action plan – Bibsam Consortium

- The aim is to facilitate the open publication of scholarly results, to bring about a redirection of payment streams from a subscriptionbased to an open access publishing system and to achieve transparency, an overview of and reduced expenses for scholarly publishing.
- that the Consortium should not sign agreements for reading and publishing in socalled hybrid journals, and instead only negotiate for publication in open access journals; this approach should be implemented from 2026 and apply to all open journals, regardless of publisher
- that new pathways to open publishing are promoted and supported and alternative business models are developed, and that researcher-driven journals that want to migrate from traditional publishers to other platforms are supported
- that publication occurs under an open license, in accordance with the FAIR principles, and that copyright conditions to promote open access, for example via socalled secondary publication rights, are explored




